
#### Historic Student Rotarian Report (1979)

Al says he really appreciates our club's hard work to serve our community, and he presents our Pres. with a memento coin honoring him. Then, he gives \$100 to PHF. This unexpected gift prompts Jim to ask Greg, "Does the Police Dep't. have any coins, now?" Greg says yes, they have a hole and come on a bracelet (maybe not the kind of gift Jim really wants.) Jack admonishes Al that our tradition is to praise the Pres. before, not after, his term.

Jim praises our town for historical support of those in need, even going to far as to compliment Lions, prompting Hale to say, "He's really worried about demotion."

Wayne talks about teaching songs to his employee fresh out of high school, Jim Mac. Then, he says he forgot Al's name at Endive event, asked 3 others but they couldn't remember. Jim Mac describes indelicate lesson he learned working for Wayne on how to pick up 3 guys with one hand. Wayne quickly gives \$20 to General Fund.

#### **Program**

Pres. Jim asks, "Where's Donna?" Our program chair, Jim Nordin, says City Hall's closed, today. Employees work 80 hours in 9 days: 8 days of 9 hours plus 1day of 8 hours, giving them a 10th day (Friday) off. Donna's day off is today, so Jim fills in for her. Jim, who serves as our City Treasurer, presents a talk on our city's draft budget.

While our auditors used to make 100 adjustments

in our books, this year under Donna Lee's watch, the auditors needed no such adjustments, making our city look better, and providing the Council with much more accurate information.

While we are now caught up and current with our audits (no more than 6 months following fiscal year), we've recently been 21 months behind. Pres. Jim chimes in, "Maybe they should work Fridays, huh?"

Unfortunately, errors are still being made at the entry level, but our accountants are catching them before they get into our financial statements.

Rio Vista's financial picture isn't rosy; the City lost 43% of revenue 7 years ago with the housing market crash. Then, Measure O saved us with a ¾ cent sales tax for 5 years, ending furloughs and filling vacant positions. The first of these funds arrived in June, 2013. The City was urged to use them for one-time expenses, but they were used for salary increases. In 2014 salary expenses increased by \$1M, most of which is attributable to pay raises, filling positions and taking people off furlough. But, revenues increased by \$600K, putting us \$400K in the hole. Without Measure O our deficit would now be \$872K, but it's actually \$216K in the General Fund.

Up to 2015 the city paid 100% of employees' benefits (PERS, Social Security, Medicare and medical.) It was the only city in CA to do that. Following a new settlement, all employees are paying their full PERS, and  $1\frac{1}{4}$ % of their Social Security and Medicare. Next year, it will go up to  $2\frac{1}{2}$ %, with the ultimate goal that employees will eventually pay their full share.

PERS is an unfunded liability, but the city is funding it at 19% + \$175K annual "catch up" fee. Between giving employees pay raises and requiring them to pay their share of PERS, the city will receive a net increase in revenues. The year ending 2016 will have a small surplus, but the year ending 2017 will have a small deficit, including Measure O funds. The following year, Measure O expires, and we'll loose revenues of about \$656K.

With improved bookkeeping procedures, the city is able to be much more proactive in utilizing all special funds for their intended purposes, leaving general funds untouched. Jim is hopeful that city will endorse a new 5-year measure similar to Measure O when it expires.

The city gets ¼ of the property taxes; the county and state get the rest. When a house sells, the city waits 1 year before it gets its share. Jim's suggestion: the city

needs to sell its property that will generate retail sales tax.

The total city budget is \$5.5M. That breaks down to \$1,300/year or \$115/month/house for police, fire & streets.

Jim's take on city finances: "This is really an interesting problem, but I don't have any idea what to do about it."
